Objective and Investment Policy

Objective

To generate long term (5 years or more) capital growth.

Strateay

 The Fund invests in a concentrated portfolio of 20-40 companies selected using a combination of economic, industry and stock specific analysis.

Investment Policy

- The Fund invests at least 80% in shares of Russian companies. These are companies which, at the time of purchase, are incorporated, domiciled, listed or conduct significant business in Russia. The Fund may also invest up to 20% in companies outside of Russia, as well as in other eligible asset classes as detailed within the prospectus. The Fund Policy complies with the IA Specialist Sector guidelines. For a definition of this IA Sector please see https://www.theia.org/industry-data/fund-sectors/definitions. Investors can compare the performance of the Fund against the MSCI Russia 10/40 Index. This index is a relevant potential performance comparator for investors because of the similarity of the investment universe.
- Any income the Fund generates will be reinvested to grow the value of your investment.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within five years.

Shares can be bought or sold on any working day in London.


