What is this product?

The fund is a compartment of MFS Meridian® Funds established in Luxembourg as an investment company with variable capital (Société d'Investissement à Capital Variable or "SICAV"). The assets of each compartment are segregated by law. The fund qualifies as an Undertaking for Collective Investment in Transferable Securities (a UCITS fund).

The fund has no fixed maturity date. The recommended holding period of the fund is 10 years.

You may request to redeem your shares, on any business day of the MFS Meridian Funds, in the currency in which they are denominated, at their net asset value. You may exchange your shares into shares of another class of the same or another fund of the MFS Meridian Funds having the same fee structure (and in certain cases, into classes with a different fee structure). An exchange within the same fund must be into a class with the same currency denomination.

Information about other classes of the fund available in your country is available at meridian.mfs.com or from your financial intermediary. The fund's depositary is State Street Bank International GmbH, Luxembourg Branch. Objective

The fund's objective is total return, emphasizing income but also considering capital appreciation, in U.S. dollars.

Investment Policy

The fund invests primarily in a range of debt instruments and equity securities, including convertibles and real estate-related investments. The Investment Manager allocates investment based on its interpretation of economic and market conditions, fiscal and monetary policy and asset class or security values. When its assessment of the relative attractiveness of asset classes and markets is neutral, the fund's exposure is expected to be approximately 15% in debt instruments of emerging market issuers (including below-investment-grade), 25% in other below-investmentgrade debt, 15% in investment-grade corporate debt, 10% in U.S. Government securities, 20% in dividend-paying equity, and 15% in real estate-related investments. Debt investment focuses on U.S. Government securities (including mortgage-backed), belowinvestment-grade debt instruments, emerging market debt and investment-grade corporate debt of developed market issuers. Up to 100% of the debt portion may be in below-investment-grade debt. Equity investment focuses on dividend paying equity securities. The fund generally focuses equity investment in larger companies, and selects them primarily based on blending fundamental analysis of individual issuers and instruments, and quantitative research based on models that systematically evaluate issuers and instruments. Real estate-related investment focuses primarily on equity of closedended real estate investment trusts (REITs) and equity of other real estate companies, but the fund may also invest in mortgage REITs

and other transferable securities of real estate companies. The fund will promote an environmental characteristic within the meaning of Article 8 of Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector ("SFDR") (see the fund's Prospectus and website for more information). The Investment Manager may also consider environmental, social and governance (ESG) factors in its fundamental investment analysis alongside other factors. The fund will not extensively or primarily use derivatives to achieve the fund's investment objective or for investment purposes.

The Investment Manager's analysis, development, and use of quantitative models, selection of investments, and its strategy to blend fundamental and guantitative research may not produce the intended results. Proprietary and third-party quantitative models may not produce the intended results due to the factors used in models, the weighting of each factor, changes from historical trends, changing sources of market returns or risk, and technical issues. Prices of debt instruments can vary significantly due to changes in interest rates, issuer credit quality and other factors. Mortgagebacked securities and securitized instruments can vary due to changes in the credit quality of underlying mortgages and timing of principal and interest payments. These risks may be higher for below-investment-grade debt. Emerging markets can be more volatile and less liquid than developed markets. Equity securities can vary significantly due to issuer, market, economic, industry, political, geopolitical, public health, and regulatory conditions. This risk may be higher where the fund invests in a specific country or region. Larger value companies may underperform the broader market during certain stages of the market cycle. The risks of REITs include risks of direct ownership of real estate and the real estate industry. REITs use leverage, which increases risk and may adversely affect issuer operation and market value when interest rates rise. Changes in currency rates can significantly affect the value of your investment, and the financial condition of issuers. Derivatives can be highly volatile and involve leverage. Losses from derivatives can be substantially greater than the original cost.

The fund's benchmarks, Standard & Poor's 500 Stock Index (USD) and a custom blended benchmark, have been designated for performance comparison only. Although the fund's investments will generally be represented in the benchmark, components are likely to be weighted differently from the benchmark and the fund is likely to invest outside of the benchmark to take advantage of attractive investment opportunities. The fund is actively managed within its objectives and the investment strategy will not restrict the extent to which portfolio holdings may deviate from the benchmark. It is expected that the fund's deviation from the benchmark will be significant.

Currency Hedging

MFS will generally enter into currency hedging transactions for this class with the aim to reduce exchange rate and return fluctuations




Distributions
