What is this product?

Type

This product is a fund of Nordea 1, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The fund is established for an unlimited duration.

The Board of Directors may compulsorily redeem or merge all the shares of the fund or share class. Circumstances under which such decision would occur are available in the fund's prospectus and accessible via www.nordea.lu. "Legal" section.

Objectives

Investment Objective The fund's objective is to provide shareholders with investment growth in the long term and create positive environmental impact.

Investment Strategy In actively managing the fund's portfolio, the management team focuses on companies that based on a quantitative and qualitative evaluation of available data, are involved in economic activities that contribute substantially to at least one of the objectives of the EU ESG Taxonomy while not significantly harming other sustainable objectives and meeting minimum social safeguards, and that appear to offer superior growth prospects and investment characteristics.

Investment Policy The fund mainly invests in equities of companies from anywhere in the world. Specifically, the fund invests at least 75% of total assets in equities and equity-related securities. The fund will be exposed (through investments or cash) to other currencies than the base currency

Derivatives: The fund may use derivatives for hedging (reducing risks), efficient portfolio management and to seek investment gains.

Usage of Total Return Swaps None expected

Techniques and Instruments Usage : None expected

Benchmark MSCI ACWI Index (Net Return)

Benchmark use The benchmark is used for performance comparison only and the investment manager may freely select the securities that it will invest in. Risk characteristics of the fund's portfolio may bear some resemblance to those of the benchmark. The fund uses a benchmark which is not aligned with the environmental and social characteristics of the fund.

Responsible Investment The fund has sustainable investment as its objective as per Article 9 of the EU Sustainable Finance Disclosure Regulation (SFDR). Further information is available in the fund's prospectus and on www.nordea.lu. Nordea Asset Management conducts a thorough due diligence on external data vendors to clarify applied methodologies and verify data quality. However, as the regulation and standards of non-financial reporting is rapidly developing, data quality, coverage and accessibility remains challenging - especially for smaller companies and less developed markets.

Redemption and Dealing: Any investor may redeem its shares in the fund on demand, on a daily basis.

Distribution policy: This share class is not distributing dividends. Income from investments is reinvested.

Base Currency: The fund is denominated in USD. Investments in this share class settle as well in USD.

Intended retail investor

This share class is not intended to retail investors and solely accessible to institutional investors under the conditions set out in the fund's prospectus and/or specific agreement. This share class is intended for institutional investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely. Recommended Holding period: 5 years. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile.

Depository: The fund depository is JP Morgan SE - Luxembourg branch.

Further information: This Key Information Document is prepared for a share class. Assets and liabilities of each fund of Nordea 1, SICAV are segregated, meaning that your investment in this fund is only impacted by profits and losses in this fund. What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

We have classified this Fund as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the Fund's capacity to pay you.

Be aware of currency risk. In some circumstances you will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if Nordea Investment Funds S.A. is unable to pay out?

In the event of our insolvency, the fund's assets in the safekeeping of the depositary will not be affected. However, in the event of the insolvency of the depositary, or someone acting on its behalf, the Fund may suffer a financial loss, which will not be covered by any investor compensation or a guarantee scheme. However, this risk is mitigated by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the fund.

What are the costs?

Costs over time

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should be prepared to stay invested for at least 5 years.

Redemption requests received by the Transfer Agent before 15h30 CET on any valuation day will be processed that day.

The share price will be the net asset value calculated for the day on which the transaction request is processed. Redemption requests received after the cut-off will be processed on the next applicable valuation day.
