Purpose

Type This product is a UCITS.

Term

The fund has no maturity date. The fund company has the right to terminate the management of the fund. More information can be found in the fund's prospectus.

Objectives

Investment objective The fund aims to increase the value of your investment over time and to outperform its benchmark.

Investment policy The fund is actively managed and invests primarily in corporate bonds in the European and the US fixed-income markets.

The corporate bonds that the fund invests in are mainly rated investment grade, but the fund can also invest up to 10% of its assets in bonds with non-investment grade ratings (high yield). The fund has the flexibility to adapt to changing market environments and employ relative strategies across sectors and issuers. The investments may be denominated in any currency, but most exposure to other currencies than Swedish kronor is hedged to Swedish kronor. Portfolio duration may vary from 3 to 9 years. Credit risk and sustainability analyses are part of the investment process. The return is determined by how much the fund's holdings increase or decrease in value during your holding period, which is mainly dependent on interest rates and the impact of future interest rate developments on the fund's various fixed-income securities, primarily based on maturities and creditworthiness.

The fund promotes sustainability characteristics, and is therefore classified as Article 8 according to the EU regulation SFDR (Sustainable Finance Disclosure Regulation). The fund follows the fund company's sustainability policy, which is available at www.sebgroup.lu/funds.

We compare the fund's return to the benchmark which consists of 50% Bloomberg Euro Corporate Bond Index and 50% Bloomberg USD Corporate Bond Index, a fixed income index covering US and European corporate bonds with investment grade ratings. The majority of the fund's holdings are constituents of the benchmark, but they differ in weight. However, the management of the fund is discretionary, and the investment strategy does not aim to restrict how much the fund's holdings deviate from its benchmark.

Subscription and Redemption You can normally buy and sell units in the fund every Luxembourg bank day, except December 24 and 31.

Distribution Policy The unit class is non-distributing.

Intended retail investor

This fund may be suitable for you who intends to keep your investment for at least 3 years, and who understands that the money invested in the fund can both increase and decrease in value. It is therefore not certain that you will get back all the invested capital. In order to invest in the fund, it is not required that you have any special prior knowledge or experience of mutual funds or financial markets.



What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level.

Be aware of currency risk if you invest in a share class denominated in a currency that is different from the official currency of the country where the share class is being marketed. You will then receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

The figures shown include all the costs of the product itself, but possibly not the costs of your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product/a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment in the product/a suitable benchmark between 30 November 2020 and 30 September 2022.

Moderate: this type of scenario occurred for an investment in the product/a suitable benchmark between 31 July 2014 and 31 July 2017.

Favourable: this type of scenario occurred for an investment in the product/a suitable benchmark between 31 August 2013 and 31 August 2016.

What happens if SEB Investment Management AB is unable to pay out?

According to law, the fund's assets may not be stored by the fund company. Instead, each fund must have a specific depositary that takes care of the safekeeping of the fund's assets. In the unlikely event that the fund company goes bankrupt, the management of the fund is taken over by the depositary. In such a scenario, there is no arranged compensation or guarantee scheme for investors in the fund.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is included as part of another product, e.g. unit linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 100,000 SEK is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.0% before costs and 2.1% after costs. We may share part of the costs with the

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The fund has no requirement for a minimum holding period, but since it invests in fixed income, it is suitable for a short to medium term investment horizon. You should be prepared to hold your investment in the fund for at least 3 years. You normally have the opportunity to sell your fund units all bank days in Luxembourg except December 24 and 31 without any extra fee.
