Objectives and investment policy

Objectives

To provide long-term capital growth through exposure to companies located in frontier markets throughout the world. Long-term perspective, fundamental analysis and active stock-picking are three main pillars of our investment philosophy.

Investment policy

The sub-fund will invest at least 75% of its assets directly or indirectly in equity or equity-related securities (such as, but not limited to, ADRs and GDRs) of companies domiciled in frontiers markets or that exercise a significant part of their economic activity there. For the purpose of this sub-fund, frontier markets are defined as less advanced and less accessible emerging market countries that are included in Frontier Markets-related indices.

The sub-fund may also invest in any country which is classified as an Emerging Market, or any other market not yet classified as Frontier

Markets, but which, in the opinion of the Investment Manager, demonstrates economic characteristics of countries included in the Frontier Markets-related indices.

The reference currency of the sub-fund is expressed in EUR. The currency of the share class is expressed in SEK.

The investor may subscribe and redeem shares on each bank business day in Luxembourg.


